## Highlights October 2022 – December 2022

NCDC has sanctioned and released financial assistance of **₹51280.48** Crore and **₹18095.17** Crore respectively during the 3<sup>rd</sup> quarter of FY 2022-23.

- The 220th, 221st and 222nd meeting of Board of Management, NCDC were held on 18 October, 2022, 15 November, 2022 (through circulation) and 21 November 2022 respectively.
- NCDC has launched two new schemes after getting approval from the 220th Board of Management meeting held on 18 October, 2022:



## Training Programs for NCDC CBBOs on Implementation of CSS- Formation and Promotion of 10,000 FPOs


