National Cooperative Development Corporation (NCDC) hi India Sawrkar-in Act of the Parliament 1963 hmang thuneihna sang ber (apex level statutory autonomous institution) tur a a din a ni. Cooperative te hmasawnna tur ruahman (planning) leh chutiang ruahmanna heng thlai thar chhuah kawng ah te, a sawngbawl kawng ah te, a hrakh chhuah kawng ah te, ram pawn a thlai leh buh-bal thawncchhuah leh chawkluh kawng ah te, industry bungraw ngaihtuah kawng ah leh ran vulh chungchang bakah heng damdawiin (hospital) leh hriselna lam enkawlna din kawngah leh hetiang zirna in din (health care and education) leh a dang ah te cooperative kalphung (principle) hmanga hma la turin. NCDC hi Ministry of Agriculture and Farmers Welfare, Government of India inrelbawlna hnuai a awm niin, pawisa faia tanpuina hi, cooperative society tier pathum; Primary, District leh Multi-State level cooperative te hnen ah a pe thin a ni.

National Health Policy 2017 in a tum ang a hriselna inenkawlna huang kil tin atang leh zau zawk a tih changtlun hi, he Scheme pawh hianin thlurbing a tum chu a ni a: healthcare service tih changtlun, natna leh damlohma chi hrang tam tak lak a inven him, hmanraw tha zawk neih, human resources lama tan lak, inenkawlna lama hmasawnna; helam hawi zawng a finna, mitin tan healthcare man tlawm zawk, mi tam zawk pan theih-hospital, healthcare, medical lam zirna, nursing zirna, paramedical zirna, health insurance leh holistic health system AYUSH leh a dang te ah hian tan lak tum a ni. Amaherawhchu, zirchianna an neihna ah pawisa neih tawk loh avangin cooperative Hospital tam zawk te chuan rahbi thar rap thei lovin medical zirna college MBBS, BDS, BAMS, BHMS, BPT & BUMS leh PG/DNB zirna din lamah harsatna an nei a ni tih hmuhchhuah ani a. Hemi hre reng chung hian NCDC chuan AYUSHMAN SAHAKAR Scheme duang chhuak in, a thil tum te chu:

- a) Cooperative society te kal tlang a holistic healthcare man tlawm zawk a mipui te pek.
- b) Cooperative society te kal tlanga AYUSH leh a kaihhnawih te hmasawna dap pui.
- c) National Health Policy tih hlawhtlin na kawnga cooperative societies te tanpui.
- d) National Digital Health Mission hma lak na a cooperative te an tel ve theih nan a puuh.
- e) A huap zau thei ang ber a cooperative ten hriselna enkawlna huanga ke an pen ve theih nan heng, damdawi lam zirna-in din kawngah te (education), damlo te tan a awlsam zawkna kawng hrang hrang thisen-zun-ek, CT Scan etc. (services) leh insuarance leh a kaihhnawih thil dangah te hmalak.

 - ix) Physiotherapy centre.
 - x) Mobile Clinic Service.
 - xi) Insawizawina lam Health Club leh Gym.
 - xii) AYUSH damdawi lam siam chhuahna.
 - xiii) Drug testing laboratory.
 - xiv) Dental care centre (ha lam).
 - xv) Ophthalmic care centre (mit lam).
 - xvi) Laboratory service.
 - xvii) Diagnostic service.
 - xviii) Blood Bank/ Transfusion service.
 - xix) Panchkarma/ Thokkanam/ Kshar sutra therapy centre.
 - xx) Regimental Therapy of Unani (Ilaj Bil Todbeer) centre.
 - xxi) Maternal health leh Childcare service, nu-nau hriselna.

- 2) Nitin an hnathawh nan a an mamawh leina tur margin money, khing para-1 leh a chung lama mite tan.
- 3) Working capital, ni tin hna thawh nan.

Eligibility (dilthei tur te):

India ram danpui hnuiaia State/Multi State Cooperative Societies Act hnuai a in register cooperative society-te leh an bye-law a hospital/ healthcare/ health education lam a hma la thei tura dan mumal tak nei te leh, NCDC in he scheme guidelines a zam ang tlin society ten an dawng thei ang.

NCDC hnuiaia tanpuina hi State Sawrkar/ UT Administrations kal tlang in emaw cooperative society, NCDC Direct Funding guideline zawm tluantling te tan, direct in an hmu thei ang.

He scheme hi scheme leh programme dang Government of India/ State Government leh Funding Agency dang te nen a thlun zawm theih (dovetailing).

Loan rulhunchhung

Rate of Interest

A dil hunlai azira NCDC in circular hmanga interest rate a bituk ang zel ani ang. Cooperative society-a mipa te aia hmeichhe member tam zawkna ten loan hun chhung zawnga hmeichhia an tam zawk tluan a, a hun tak zel a an rulh chuan, NCDC hian lawman leh cho phurna angin, interest rate hi 1% in a tih hniam sak thei bawk ang.

Security

NCDC atanga tanpuina hi State Government kal tlangin emaw Direct Funding kal tlang in a laktheih a. Direct Funding zawng a loan lak anih chuan cooperative society te chuan NCDC hnen ah dahkham a nei tur a ni a, he a hnuiaia tarlan pakhat emaw a aia tam te hi loan dahkham atan an hmangthei ang, chung te chu:-

- a) Cooperative society in dahkham tur hmun-hma leh thil dang a neih te baka, he scheme hnuiaia project hmanga in leh thil dang (assets) a din te pawh dahkham atana pawm tel nghal ani ang. An thil dahkham erawh an loan lak zah aia a let 1.5 tam ani tur a ni.
- b) State/Central sorkar in quarantor-a an tan sakin.
- c) Nationalized bank emaw scheduled bank a FDR an neih hmanga NCDC atanga an loan lak zah let 1.2 aia tam dahkham tur cooperative ten an nei ani tih an nemngheh in.
- d) Central PSU's/ Statutory bodies/ CSR Foundations of Central PSU' ten guarantor-a an tan sak in.
- e) Scheduled bank/ Nationalized bank ten gurantor-a an tan sak in.
- f) Sawrkar in a bond/securities hmanga NCDC loan an lak zat let 1.2 a dahkham sak in.

Subsidy
