निविदा सूचना

राष्ट्रीय सहकारी विकास निगम (एनसीडीसी), 4, सीरी इंस्टीट्यूशनल एरिया, हौज़ खास, नई दिल्ली-110016, द्वारा मुख्यालय में आवश्यकतानुसार टैक्सी को किराये पर उपलब्ध कराने हेतु दो वर्ष की अवधि के लिए दर अनुबंध (Rate Contract) के संबंध में बोली, ऐसे प्रतिष्ठित ट्रैवल एजेंसियों से CPPP पोर्टल के माध्यम से ऑनलाइन बोलियाँ आमंत्रित की जाती हैं, जिनका कार्यालय एनसीडीसी मुख्यालय से 5 किलोमीटर की परिधि के भीतर स्थित हो, जिनके पास पर्याप्त वाहन (कंपनी के नाम पर न्यूनतम 25 वाहन) उपलब्ध हो तथा इस क्षेत्र में पर्याप्त अनुभव हो, अनिवार्य पात्रता मानदंड निम्न अनुसार हैं :

- I. बोलीदाता का पिछले तीन वित्तीय वर्षों, अर्थात् 31 मार्च 2026 को समाप्त होने वाले पूर्ववर्ती वित्तीय वर्षों (वित्तीय वर्ष 2023-24, 2024-25 एवं 2025-26) के दौरान औसत वार्षिक वित्तीय कारोबार ₹40 लाख से कम नहीं होना चाहिए। इसके समर्थन में संबंधित अवधि की प्रमाणित लेखापरीक्षित (Audited) बैलेंस शीट अथवा चार्टर्ड अकाउंटेंट/कॉस्ट अकाउंटेंट द्वारा जारी प्रमाण-पत्र, जिसमें संबंधित अवधि का कारोबार अंकित हो, बोली के साथ संलग्न किया जाना आवश्यक होगा।
- II. बोलीदाता के पास बोली खोलने की तिथि से पूर्व समाप्त मार्च 2026 (31.03.2026) तक के कम-से-कम तीन (03) वर्षों का अनुभव किसी केंद्रीय/राज्य सरकार के संगठन अथवा सार्वजनिक क्षेत्र के उपक्रम (PSU) को इसी प्रकार की सेवाएँ प्रदान करने का होना चाहिए। प्रत्येक वित्तीय वर्ष के दौरान सेवाएँ प्रदान किए जाने के समर्थन में संबंधित कार्यदेश/अनुबंधों की प्रतियाँ बोली के साथ संलग्न की जाएँ।
- III. एजेंसी का संबंधित प्राधिकरण के साथ विधिवत पंजीकृत होना आवश्यक है तथा इसके समर्थन में पंजीकरण प्रमाण-पत्र की प्रति प्रस्तुत करनी होगी।
- IV. बोलीदाता का परिचालन कार्यालय एनसीडीसी, 4, सीरी इंस्टीट्यूशनल एरिया, हौज़ खास, नई दिल्ली-110016 से 5 किलोमीटर की परिधि के भीतर स्थित होना चाहिए।
- V. बोलीदाता भारत में लागू विधि के अनुसार पंजीकृत कंपनी हो तथा कम-से-कम तीन वर्षों से अस्तित्व में हो। कंपनी के पास वैध पैन एवं जीएसटी पंजीकरण होना अनिवार्य है।
- VI. बोलीदाता किसी भी सरकारी विभाग द्वारा Blacklisted नहीं होना चाहिए तथा उसके विरुद्ध Liquidation, Court Receivership अथवा अन्य कोई कार्यवाही लंबित नहीं होनी चाहिए और वह Bankrupt घोषित नहीं होना चाहिए। इस आशय का निर्धारित प्रारूप में एक घोषणापत्र बोली के साथ प्रस्तुत करना अनिवार्य होगा।

TENDER NOTICE

National Cooperative Development Corporation (NCDC), 4, Siri Institutional Area, Hauz Khas, New Delhi – 110016 invites online bids through CPPP Portal from well-established travel agencies stationed locally within 5 km radius of NCDC Head office, Hauz Khas, New Delhi having sufficient fleet of taxis (minimum of 25 taxis in the name of the company) and experience in the field, for **rate contract for hiring of taxis on 'as and when required basis at NCDC, Head Office for a period of two years**. The prospective bidder shall fulfil the following mandatory eligibility criteria:

- I. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year (FY- 2023-24, 2024-25 & 2025-26), should be ₹40 lakhs. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant /Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid.
- II. The bidder must have experience for three (03) years ending month of March prior to the bid opening (31/03/2026) of providing similar type of services to any Central / State Govt. Organization / PSUs. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- III. The agency should be registered with the concerned Authority and should furnish a copy of registration certificate in support thereof.
- IV. The bidder must have operating office within 5 km radius of NCDC, 4, Siri Institutional Area, Hauz Khas, New Delhi-110016
- V. The bidder should be a registered company in India as per applicable statute and be in existence for at least 3 years. Should have valid PAN and GST registration.
- VI. The bidder must not be blacklisted by any Government Department and should also not be under liquidation, court receivership, similar proceedings, or bankrupt. An undertaking to this effect, in the prescribed format, shall be submitted with the bid.

EMD of ₹5,000/- (Rupees Five Thousand Only) in the form of Demand Draft/ Banker's Cheque in favour of "National Cooperative Development Corporation" and payable at New Delhi, Bids submitted without valid EMD may be rejected. The MSEs firms registered with NSIC/ MSME are exempted from the payment of EMD. Copy of valid certificate must be furnished.

TERMS & CONDITIONS

1. **This tender is open to all registered reputed travel agencies stationed locally within 5 km radius of NCDC Head office, Hauz Khas, New Delhi having sufficient number of taxis (minimum of 25 taxis in the name of the company).**
2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year (FY- 2023-24, 2024-25 & 2025-26), should be ₹40 lakhs. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant /Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid.
3. The bidder must have experience for three (03) years ending month of March prior to the bid opening (31/03/2026) of providing similar type of services to any Central / State Govt Organization / PSUs. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
4. The company should be registered with the concerned authority and should furnish a copy of registration certificate in support thereof.
5. The bidder should be a registered company in India as per applicable statute and be in existence for at least 3 years. Should have valid PAN and GST registration. Self-attested copy of company registration certificate, GST, PAN number.
6. **Earnest Money Deposit:**
EMD of ₹5,000/- (Rupees Five Thousand Only) in the form of Demand Draft/ Banker's Cheque in favour of **“National Cooperative Development Corporation”** and payable at New Delhi has to be submitted along with tender documents, failing which the bid will be rejected. Earnest Money shall be forfeited in the event of any of the following situations:
 - a) If the bidder withdraws or amends his tender or increases the rates after deadline for submission of the Tender but before the validity of the tender expires.
 - b) On refusal to enter into contract after award.
 - c) On failure to furnish the required performance security or
 - d) If the work is not commenced on the date of starting the work after the work is awarded.
 - e) Once the tender is submitted, no tenderer will be allowed to withdraw the tender. Even if, any tenderer withdraws the tender, E.M.D. of that tenderer will be forfeited in full.
 - f) Any error on the part of the tenderer while quoting the rates will not be accepted as an excuse for refusal to execute the order for any or all items, if order is placed on the basis of the quoted rates. For refusal of the order, the EMD of the tenderer will be forfeited in full.
 - g) No interest is payable on the EMD under any circumstances and will be returned on completion of tendering process.
7. The successful bidder shall furnish a refundable security deposit of **₹25,000/- (Rupees Twenty Five Thousand Only)** in the form of Bank guarantee or DD in the favor of **“National Cooperative Development Corporation”** and payable at New Delhi”. Security Deposit shall be returned to the company after successful completion of the contract. If successful bidder fails to comply obligations of contract in that case Security Deposit will be forfeited. No interest shall be payable on the Security Deposit.

8. Each Bidder will submit only one tender either by himself or as a partner in Joint venture company.
9. Performa for furnishing rates for hiring of taxis on 'as and when required on call basis at NCDC, Head Office is enclosed. In case bidders need any clarification, the office of Chief Director (Genl. Admin.), NCDC as indicated above may be visited on any working day (Monday to Friday) between 11.00 AM to 4.00 PM.
10. Opened/stapled/improperly sealed/ tenders or received after expiry of last date shall not be entertained.
11. During evaluation of bids, the NCDC may, at its discretion, ask the Bidder for a clarification of its bid. There will be no change in prices or substance of the bid shall be sought, offered or permitted.
12. It will not be permissible for the companies to which the work is outsourced to further outsource the work.
13. NCDC reserves the right to select or reject any or all bids without assigning any reasons thereof. Conditional & incomplete bids shall summarily be rejected.
14. There should be no overwriting in the bidder's offer. The initials of the bidder's authorized person and the seal of the bidder's company must verify each correction.
15. Any bid received by NCDC after the deadline for submission of bids prescribed will be rejected and/or returned unopened to the Bidder. NCDC shall not be responsible for any postal/ transit delays.
16. No advance payment will be made. The payment will be released after satisfactory completion of service and submission of bill and effort shall be made to make payment at the earliest on the receipt of a clear & corrected bill.
17. Toll, parking charges will be paid extra at actual by NCDC on submission of bills for same.
18. The contract can be terminated by this office at any time without assigning any notice/reason or without giving any reason. If the work of the company is found unsatisfactory during the period of this contract, decision of the Competent Authority of this office shall be final and binding on the company on contract.
19. In case of any breach of any terms and conditions by the successful bidder, NCDC reserves the right to cancel the contract by giving notice. In the event of the cancellation of Work Order, Security Deposit lying with the Corporation will be forfeited.
20. In case of breach of any terms and conditions of the tender document then without prejudice to any other claim that NCDC may have against the bidder, NCDC may blacklist the company for a period of 2 years.
21. **Bidder should submit certificate/undertaking as per the format to the effect that company is neither blacklisted by any government department nor any criminal case is registered against the company.**
22. **The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to submit undertaking to this effect with bid.**
23. Penalty: In case of non-compliance with any of the terms and conditions of the contract, a penalty of ₹1,000/- on every occasion will be imposed.
24. The contract is initially for the period of two year from the date of award of work. The contract period may be extended further, subject to satisfactory services on mutually agreed Terms & Conditions.
25. In case two or more companies are found to have quoted the same rates, NCDC shall decide about the company to which the offer shall be granted based on the past credentials/report on the past performance of the company, and length of experience etc. The decision of the competent authority of NCDC shall be final.
26. The rates will remain unchanged during period of contract for a period of two year. Upward change in rates will not be considered due to any hike in petrol/ diesel prices during the period of contract.

27. The agency should abide by rules laid down by any authority relevant to the deployment of taxis.
28. **The calculation of mileage/ distance will be from the reporting/ starting point of the user i.e NCDC Head Office, Hauz Khas, New Delhi and closing at NCDC Head Office or Registered Office of the bidder whichever is closer to the point where the user completes his / her journey and it will not be calculated on garage to garage basis.**
29. The company shall arrange the taxi as per NCDC requirement within one hour from receiving the instruction over phone by the concerned officer, as and when and where required.
30. The services shall be provided on 24x7 basis. No mileage will be allowed to drivers for lunch/ breakfast or for filling of petrol/diesel/CNG (Fuel) etc. Hence, the Service Provider will ensure that the fuel tank of taxi provided is fully filled up before sending the taxi for duty.
31. The taxis provided must not be older than 03 (three) years and should have a valid Registration Certificate along with other papers and comprehensive insurance during the period of contract. If the taxis so provided are not found as per standard, the same are to be replaced by the company at their own cost within the stipulated period, failing which the cost shall be recovered from subsequent bill. Delayed supply/non-compliance of complete order may also lead to cancellation of Contract.
32. The transport company will be liable to pay any excess costs incurred for hire of taxis or services not delivered in time.
33. The driver should observe all the etiquette and protocol while performing the duty. He must be in neat uniform with name badge to be provided by the company and should have mobile phone connectivity for which no separate payment shall be made.
34. The company must be able to provide required taxis on odd even days whenever implemented by Government of NCT of Delhi according to odd even days.
35. After receiving the confirmed offer from NCDC, the Company will give its acceptance and submit refundable security deposit within 10 days from the date of receiving the confirmed order.
36. **Bid Validity:** The bids shall be valid for a period of 120 days from the date of opening of the tender.

37. **ARBITRATION**

In the event of any dispute or disagreement over the interpretation of any of the terms herein above contained or claim of liability, the same will be referred to an arbitrator to be appointed by the Managing Director, NCDC, whose decision shall be final and binding upon both the parties. Such reference shall be deemed to be a submission to arbitration under the Arbitrations and Conciliations Act 1996. The venue of arbitration shall be New Delhi. Subject here to the court in New Delhi shall have exclusive jurisdiction to the exclusion of all other courts.

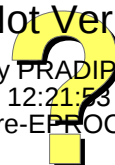
